The SCA in a Nutshell

- An act that requires Federal contractors to pay service employees no less than the wage rates and fringe benefits found prevailing in the locality or, where existing, the rates contained in a predecessor contractor's collective bargaining agreement.

Historical Underpinnings

- The Service Contract Act (SCA) provides exemptions for concessions contracts “principally for the furnishing of food, lodging, automobile fuel, souvenirs, newspaper stands, and recreational equipments to the general public”

Getting Into National Park Concessions

- Transportation workers brought forth cases to DOL requesting application of the SCA
 - At Denali in 2002
 - At Alcatraz in 2005
- DOL issued administrative determinations stating that the SCA applies to the concession contracts
 - At Denali in June 2006
 - At Alcatraz in September 2006

SCA Implementation Impacts

- For those contracts principally for non-exempted services:
 - Wage determinations will be made on a contract by contract basis
 - Prevailing wages, benefits, and overtime paid regardless of seasonality or part time employment status

This website provides a single location for federal contracting officers to use in obtaining appropriate Service Contract Act (SCA) and Davis-Bacon Act (DBA) wage determinations (WDs) for each official contract action. The website is available to the general public as well. Guidance in selecting WDs from this website is provided in the WDOL.gov User's Guide.

Alternatively, the WDOL.gov Program also provides contracting officers direct access to the Department of Labor's (DOL's) "e98" website to submit a request for SCA WDs for use on official contract actions. In some instances, the WDOL.gov Program will not contain the appropriate SCA WD, and contracting officers will be directed to use DOL's e98 website in order to obtain the required SCA WD. DOL will provide the contracting officer with an SCA WD through the e98 system.
